Background

In September 2013, the Healthy Caribbean Coalition (HCC) was awarded a grant under the NCD Alliance / Medtronic Philanthropy programme "Strengthening Health Systems, Supporting NCD Action". The programme was aimed at strengthening national and regional civil society NCD advocacy efforts in Brazil, South Africa and key Caribbean Community Countries (CARICOM) to raise demand and advocate to governments to strengthen health systems through an integrated approach to action on NCDs. The HCC is currently in its third year of funding under this programme. The goal of this 3rd grant is to 'Improve the capacity for effective, targeted Civil Society led NCD prevention and control in the Caribbean'. The specific objectives are: To increase evidence-based NCD CSO led advocacy in the Caribbean; To strengthen Patient Engagement and patient led advocacy among members CSOs; To expand and strengthen the Healthy Caribbean Coalition civil society network; To support CSOs advocacy and action around strengthening of regional health systems and universal health coverage; To strengthen the regional multisectoral NCD response.

Specific objective 3: 'To expand and strengthen the Healthy Caribbean Coalition civil society network', contains a number of activities including activity 3.5: Hold a face to face / virtual regional meeting of HCC Health NGO membership with a focus on coalition building around HCC's 2017-2021 Strategic Plan (inc. strengthened NCD advocacy in the post 2015 era).

This HCC Strategic planning meeting, linked to Activity 3.5 of the HCC/NCDA project proposal, aims to bring together HCC member civil society organisations (CSOs) to contribute to the development of the HCC 2017 Strategic Plan. Prior to the meeting, the HCC undertook a detailed mapping of member CSO capacity; the findings of which will be presented at the planning meeting and inform the 2017-2021 strategic plan. The major output of this meeting will be a second draft HCC Strategic Plan for 2017-2021.

Meeting Goal, Objectives & Expected Outcomes

The **goal** of this meeting is: To bring together HCC members and partners to contribute to the development of a draft HCC Strategic Plan for the period 2017-2021.

The **objectives** of the meeting are to:

- 1. Review preliminary findings from the HCC CSO capacity and information needs assessment.
- 2. Agree on HCC strategic priority areas.
- 3. Develop draft strategy with goals, objectives, expected outcomes, and activities.

The outputs and expected outcomes are:

1. Draft HCC Strategic Plan for the period 2017-2021.

2. Increased sense of CSO members' engagement and ownership in the HCC strategic planning process.
