### **65<sup>TH</sup> ANNUAL CARPHA HEALTH RESEARCH CONFERENCE**

PANDEMIC, NCDs AND CLIMATE CHANGE: The Caribbean's Triple Threat

In the Caribbean, non-communicable diseases (NCDs) are the leading cause of death and disability and take a heavy toll on societies. Climate change, is now well recognised as a threat to human health with impacts such as severe weather events and hurricanes, increases in mosquito-borne, food and waterborne diseases, water scarcity and food insecurity. Pandemics have also impacted large numbers of people in the Caribbean.

The current COVID-19 pandemic has resulted in large numbers of deaths and people being hospitalised. These crises are pushing already fragile regional healthcare systems and public health infrastructures to the limit.

Under the theme "Pandemic, NCDs and Climate Change – The Caribbean's Triple Threat", the Caribbean Public Health Agency (CARPHA) in collaboration with the Agence Française de Développement (AFD), hosted its first ever virtual health research conference, from 16 to 19 June 2021.

Using the virtual format allowed the longest running health research conference in the Latin American and Caribbean region, an extended reach allowing persons from all corners of the world to participate.

This year, for the first time, the conference was held virtually. The conference was hosted on the vFairs platform <u>https://carphaconference.vfairs.com</u> and was available in two languages, English and French.





#### **The Conference**

The conference was four days packed with 93 Oral and 78 Poster presentations from students, academia, health care professionals and CARPHA technical officers which were available to attendees. Sessions covered various aspects of:

- Climate Change
- Communicable Diseases
- Environmental Health
- Family Health

- Health Services
- Non-communicable diseases
- Nutrition
- Public Health

A total of 167 delegates registered for the Conference and 15 countries were represented. The majority of the delegates were from the Caribbean with others from the USA, the United Kingdom, Ireland, and Brazil.

#### **Opening Ceremony**

CARPHA kicked off its four-day Annual Health Research Conference on June 16 2021 with an Opening Ceremony

Dr. Joy St. John, CARPHA's Executive Director opened with remarks highlighting the conference's theme and importance of continued research and key partnerships to combat these threats.

These were reaffirmed in remarks by Emeritus Professor David Picou - Experimental Medicine, UWI and First Director of Research, Caribbean Health Research Council, Mr. Philippe La Cognata -Regional Director for the Atlantic Region, AFD and His Excellency Serge Lavroff - Ambassador of France to Port of Spain, Trinidad. A message to Conference Delegates was given by Dr. Tedros Adhanom Ghebreyesus, Director-General of the World Health Organization (WHO).





The scientific programme commenced with kevnote address "The the Caribbean's COVID-19 Response" by Dr. St. John, who provided a synopsis of the emergency of COVID-19, its declaration as a pandemic and the important public health measures and responses of the Region's Institutions including the critical role played by CARPHA as the public health agency mandated by the CARICOM Heads of Government to address this challenge.

The Opening Ceremony was followed by a noteworthy COVID-19 Panel Discussion. The session moderated by Dr. Sharon Belmar-George, Chief Medical Officer, St. Lucia included:

Day 3 of the Conference opened with a feature lecture "Ageing in the Caribbean yesterday, today and tomorrow" by Professor Dr. Denise Eldemire-Shearer of the Mona Ageing and Wellness Centre at the University of the West Indies (UWI), Mona. Chaired by Dr. Joy St. John, the lecture served as the ideal prelude to the launch of CARPHA's State of Public Health Report – Healthy Ageing. The final feature lecture of the conference "Probing in vivo Metabolism using Stable Isotope Tracer technique" was given on Day 4 by Professor Dr. Asha Badaloo of the Tropical Metabolism Research Unit, Caribbean Institute for Health Research, at UWI, Mona.

The Prize was given in his name in recognition of his outstanding contributions to research systems in the Region.






The Donald Simeon Prize was awarded to Dr. Zachary Ramsay for his paper "Quantitative Sensory Testing in the Assessment of Neuropathic Pain among Jamaicans with Sickle Cell Disease".



This year's David Picou Young Researcher Prize was awarded to Dr. Kavita Dharamraj for her paper "A crosssectional comparison of point-of-care A1CNow+ machine with laboratory HbA1c in detecting diabetes in urban communities, South Trinidad, 2019-2020".



Ms. Vonetta Nurse was awarded the Student Prize for her paper "The use and understanding of nutrition labels on sugar-sweetened beverages: A study of consumers in Kingston & Saint Andrew, Jamaica".



This year, first place in the research poster went to Dr. Shanta Bidaisee et al for "An audit of cancellation on the day surgery of orthopaedic cases at the Port of Spain General Hospital". A.M. Gordon and R Alexander-Lindo captured second place for "Hypoglycaemic & Hypotensive Effects of Jamaican Plectranthus blumei (Joseph's Coat) Crude Extracts in Normal Healthy Rats".

The ceremony concluded with a vote of thanks by Dr. Mark Sami, CARPHA's Director of Corporate Services, and a rousing Toast to the Awardees and Prize Winners.

The conference closed with the Awards Ceremony and Research Prize Presentations, hosted by the conference's Masters of Ceremony - Dr. Terri-Karelle Reid and Mr. Jason Williams.
